Commandant's Letter ~ Greetings Department of West Virginia Marine Corps League Members:



On the 9th of January 2024 I had my surgery on my right ear. This had me restricted to home confinement for about a month and a half. I am now cleared to drive and do light activities but unable to wear my hearing aid in my right ear. I hope to be able to return to normal after my follow up appointment in Huntington on the 4th of March. I hope that this has not inconvenienced anyone. Hearing problems is an unseen disability and should not be taken lightly. If you or your family members think that you have a hearing problem, be sure to have your hearing checked.

I hope all of the Detachments are well along on selling their Department Pistol Raffle tickets. My Detachment has sold over 750 of the 800 tickets that we took. Remember that ½ of the proceeds of this

fundraiser goes to the Department general fund and the other ½ goes to support the Hershel "Woody" Scholarship Foundation.

All of the Detachments should have their Department Awards Nomination packages, the Department Marine of the Year and Department Associate Member of the Year nomination packages. Commandants remember to check the Department Bylaws and Administrative Procedures as well as the instructions with each package before your Detachments vote on their nominations. If there are contradictions between the instructions and the Bylaws and Administrative Procedure then the Bylaws take precedence. Also make sure you check to see if an award is for a person, a Detachment or both before you vote. Hopefully every Detachment will send in nominations this year. Remember that your members cannot get an award unless your Detachment submits them. The MOY and AMOY must be postmarked no later than 1 March and make sure to write MOY and AMOY over the envelope flap. The deadline for submission of the Department Awards is March 30.

We still have a few of the Department of West Virginia Marine Corps League 50th Anniversary medal, ribbons and challenge coins. If you want to purchase them please contact Department Adjutant/Paymaster Leib.

My wife and I attended the National Marine Corps League Mid-Winter Conference on 21 - 24February 2024 in Arlington, VA. A Message from Sr Vice Commandant Jim McDade:

The Department Convention is less than 3 months away and we will be electing Department Officers for the upcoming year, so if you are interested in running for any Department Officer position please let me know. We will also take nominations from the convention floor.

We will also be accepting bids for the Fall & Winter Conferences and the 2025 Department Convention. We would like some different Detachments to hold the Conferences and Convention, going to the same places gets a little boring and we want all Detachments to feel like they are part of something, plus it's a good way to show off your Detachment and community. As I've said before, the conferences are a lot easier to host than the Department Convention. If there are 2 Detachments that are close together there is nothing saying you can't co-host a Department Convention or Conference. The Department Convention might require the Detachment to pay for the Conference Room and other incidental expenses, but it's not impossible. You might consider borrowing items from other Detachments; it's worth giving them a call to see if they have what you need and would be willing to loan it. Also, on the Department Website on the left side of page under Administrative Procedures, there is a link to the Department of WV Guide Book for Detachments that has a section called "guide to hosting a conference or convention" and I suggest you read that prior to submitting a bid.

Department Awards packets were distributed to each Detachment and Adjutant Leib has electronic versions if that would make it easier for your Detachment to type up your nominees and submit. Submissions still need to be mailed according to the directions, but electronic forms are available. The Department Marine of the Year and Associate Member of the Year nominations must be postmarked by the end of TODAY, March 1st. If you haven't already mailed them, you must take these packets to the post office and have the postmaster stamp it with TODAY'S postmark. All other award nominations must be postmarked by March 30th.

Every year we only have 4 or 5 Detachments submitting award nominations. We know we have more members doing great things across the state and we want to make sure that they are being recognized for their efforts, even if they don't win a Department award just being nominated makes them feel appreciated. You should also be recognizing your members at the Detachment level; it can be a simple Certificate of Appreciation, but if you don't recognize their efforts, you are doing them a disservice. It really is an encouragement to your members.



Dear Officers:

Most Detachments hold their Elections in March and Install their Officers in April (both Elected and Appointed Officers must be installed and sworn in). National MCL Bylaws recommend Elections and Installations as early September but must be completed no later than June 30 each year. There may be a month in between Elections and Installations to allow for an annual financial audit and property inventory. Please Note: Detachments are required to submit their Report of Officer Installation within 15 days after the Installation has taken place; please send me your ROI (Report of Officer Installation) signed by both the Installing Officer and the Detachment Adjutant as soon as it is completed.

Once your Officer Installation has taken place, the Adjutant-Paymaster (or Paymaster) should file the Annual Corporation Report (ACR) with the WV Secretary of State. This is an online form ONLY, and has a \$25.00 fee. If you file before your election/installation and your key Officers change, then you will have to file again and pay another fee, so Wait until after your election and installation to file! If your Detachment HAS installed your Newly Elected Officers for FY 2024-2025, and you need assistance to file this Annual Corporation Report, please contact me and I'll help you.

If your Detachment HAS installed your Newly Elected Officers for FY 2024-2025 and you know how to file on your own, then please feel free to do so, but don't forget!! <u>I need a copy</u> of the page that says you filed and it was <u>ACCEPTED</u>.

Since I report all of this to the Department Board of Trustees and on the Snapshot Report that is also distributed to the membership at the Convention in May, it is extremely helpful to me if I have your ROI and ACR by April 30th at the latest. Don't let your Detachment show as unreported.

If you have any questions, please be sure to call me - it's SO much easier to answer questions than to fix a problem, and I enjoy helping Detachments! And there are no dumb questions!

2024 Mid-Winter National Conference After Action Report

My wife and I attended the Mid-Winter National Conference on 21 February through 25 February. It was held in Arlington Virginia at the Sheraton Pentagon City Hotel.

We went on a tour of the National Museum of the Marine Corps at Quantico. They had 4 buses to take everyone down but we chose to drive as we also wanted to go to the Marine Corps Exchange. We also visited the Iwo Jima Memorial and the Tomb of the Unknown Soldier.

On 22 February 2024 I attended the Department Commandants Council. I found out that anyone can attend this meeting, not just the Commandants. They did a roll call of the Commandants and 38 of the 47 Departments were in attendance. 25 is a quorum. Some of the points discussed were:

1.) We were told that currently only 25% of the members have their email address in the Member Portal. We need to get every member's email address added to the Portal so emailed information can go straight from national to the members.

2.) They suggested that if you have a Facebook page that you have a private for members only page and a community page that anyone can see but make both so that no one can add articles without an admins approval.

3.) They have an App now that members can access on their smartphones. Currently only 850 members are using it. The App can be loaded on your phone from Apple or Google App Stores. Just search for Marine Corps League and get the free app. You login with your profile number and your last name. If you do not know your profile number (this is not your member number) see your Detachment Paymaster.

4.) The Department Judge Advocate can now email (preferred) or mail your Bylaws to Nation Judge Advocate David Porter. His email address is <u>DPorter@MCLeague.org</u>.

On 23 February 2024 I attended the General Session. This was a joint session in the morning with the Marine Corps League and the Marine Corps League Auxiliary. It started with the escorting the Organizational Heads and Distinguished guests to their seats followed by the Presentation of the Colors by the Quantico Color Guard, the Pledge of Allegiance and the National Anthem. The colors were then retired. The Chaplain open the Bible and gave the opening Prayer. We Then had a Joint Memorial Service followed by a presentation on the Chaplel of Four Chaplains.

After a break we had reports in this order from the National Judge Advocate David Porter, the National Jr Vice Commandant Russ Miller, the National Sr Vice Commandant TJ Morgan and then the National Commandant Warren Griffin. <u>Military Historical Tours</u> Presentation by Shayne Jarosz. See their ad in the last Semper Fi magazine. <u>Uniforms</u> by Ray Morrell. They are going to completely rewrite the Enclosure 3 Uniform Code in the National Administrative Procedures and also create an SOP.

<u>Veterans Services</u> by Tom Mueller. There is a LOT of information on the Marine Corps Leagues Veterans Services page. Go check it out at <u>https://www.mcleaguelibrary.org/veterans-service-officer/</u>. <u>Department of Veterans Affairs</u> presentation by two VA representatives.

<u>Young Marines</u> by Bill Davis. They get funds from the federal government. Currently waiting on the budget bill to pass. National presented them with a \$2,500.00 donation.

<u>Marine Corps League Scholarships</u> by Ronnie Broussard. They had 214 applications from all across the country. 80% were approved so 171 got scholarships. 121 Detachment from 36 Departments were represented. The students received about \$600.00 each. They have a lump sum that they get each year and it is divided by the number of recipients. This year was a little over \$102,000.00. There was one recipient from the Department of West Virginia Marine Corps League Cpl. William B. Fulks Detachment 1474. Katy M. Limanen and her sponsor was her father, Lorn Limanen. Katy received a Hershel "Woody" Williams scholarship in 2022.

<u>Marine For Life</u> by David Ossian. They actually work with all military and their spouses who need assistance.

<u>Toys For Tots</u> by David Cooper and Ted Silvester. National Jr Vice Commandant Russ Miller is the Marine Corps League liaison to the Toys For Tots Foundation.

Hershel "Woody" Williams Scholarship Foundation Report

As I have reported to the Hershel "Woody" Williams Scholarship Foundation members, Mike Lynon, Jim McDade and Scott Kirby, we have only received two scholarship applications so far. Not to worry there is still over 2 weeks to get them in.

The Scholarship application and instructions can be downloaded from the Department of West Virginia Marine Corps League web page at the link below. The application should be typewritten as much as possible except for the page that says "A brief **handwritten** life history to include school, community and church involvement, extra-curricular activities, and goals, not to exceed one (1) page."

Applications must be postmarked no later than 15 March 2024. Again tell your students to take the application into the Post Office and ask to have them postmarked by hand. Any application received after 15 March without a postmark or with a postmark after 15 March will be rejected. Please note on the back of the envelope that it is a scholarship application.

The applications will not be opened until the committee meets after the 15 March 2024 deadline. After the meeting all communication will be with the student except for a congratulatory letter to the Detachments Commandant for any student selected for the scholarship.

If you have any questions about anything, first check the instructions, second check the Department Bylaws and Administrative Procedures Chapter 3, Section 301(4) and if you still have questions then call me at 304-377-1345. Remember if there is any contradiction between the application and the Department Bylaws and Administrative Procedures then the Bylaws take precedence.

This is a one time scholarship. If you have gotten one before then you are not eligible to apply again.

Military Historical Tours and the Marine Corps League

One of the presentations at the 2024 National Midwinter Conference last week was by the company Military Historical Tours. If you look at any Semper Fi magazine you will notice that they have an ad in them. The ad includes chances to sign up for a free tour. The chances cost \$5.00 each or 5 for \$20.00. The money goes to the National Marine Corps League to help with their various programs such as Marines Helping Marines and Toys For Tots. The winner is drawn each year at the Midwinter Conference and you do not have to be present to win.

Next year Military Historical Tours will be leading a tour of the 80th anniversary of the Battle of Iwo Jima. They did not do a tour for the 79th anniversary as some volcanoes were erupting around Iwo Jima and the Japanese government canceled their permit. They reported that this may be the last time they get to do a tour on Iwo Jima. They requested that we ask all of our members to call or write their congressional representatives and ask them to insist that the Japanese government follow the guidelines set up when the island was returned in 1968 and let the tours continue.

If you chose to go on one of their many battlefield tours and you are a Marine Corps League member then you will get a 10% discount on your trip. Their website is <u>www.miltours.com</u>.

Membership, Emails and the Marine Corps League's App

1.) Some information about the Marine Corps League and membership. Currently the MCL have about 54,000 members. I read that it was 53,853 but that changes constantly. That 54,000 consists of Life Members, Regular Members, Associate Members and Dual Members. I am a Life Member of Detachment 1065 and a dual member of Detachment 1461. That means that I count as two members of that 54,000 members. If you are a dual member of 4 detachments and a regular member of your home detachment then you are counted as 5 of the 54,000 members. Currently 64% (34,560) of the members are Life Members. That number eats into the funds that National has to operate with. They get very little money each year from the life member compared to the \$20.00 for the other member types.

2.) The national database only has email addresses for 25% of the 54,000 members. They would like to get that up and have an email address for all or most of the members. If they can do that then they can change and start sending emails directly to the members instead of having to filter them down to the Division Commandant who should send it down to the Department Commandant who should send it down to the Detachment Commandant who should then send it to all of the Detachment members. If anyone drops the ball and forgets to forward the email down then the Detachment members may never see the information. I would like to challenge every Detachment Commandant and Detachment Paymaster to go out to the National Database portal and add the emails of all of your members to the database. If you do not know how to do this then contact the Department Adjutant/Paymaster Leib and she will teach you how to do it.

3.) National also has an App for smart phones and a channel on YouTube. Currently less than 900 members are using them. They would like to have a lot more members accessing them. Please Detachment Commandants tell your members at your next meeting about these useful tools. For YouTube you just go into YouTube and search for Marine Corps League. You can then look at all of the information that they have available. To get the App, if they have an iPhone, iPad or iPod got to the Apple Store and search Marine Corps League and get it. If they have an android phone then go to Google Play and search Marine Corps League and get it. For both the sign in is their Profile Number and last name. If they do not know their Profile Number then tell them to see their Detachment Paymaster.

Overview of Required Reports Following Annual Officer Installation

Following reports and where they are sent:

*Financial Audit and Property Inventory should be conducted before Installation; verification must be sent to Department Adjutant prior to Convention, preferably no later than April 30

*Triennial Certification of ceremonial rifles every 3 years (only detachments having rifles) sent to TACOM.

*Copy of Monthly Detachment Minutes should be forwarded to Department Commandant and Department Adjutant following every meeting as per Department Bylaws.

*Paymaster Report due each membership meeting showing deposits, debits, credits, & outstanding transactions

*Membership update to Dept Jr Vice Commandant Quarterly, submitted by the Det MRT/Det Jr. Vice

*Report of Officer Installation (ROI) completed and Original mailed to Department Adjutant by April 30th.

*Letter to Bank to change signature cards adding new Commandant and Paymaster after a motion to make change approved by members. A copy of the Det Minutes showing this vote should accompany the letter.

*Annual Corporate Report will be completed ONLINE <u>after</u> Officers are installed; form is on the WV Sec of State website at cost of \$25.00 (email confirmation to Dept Adjutant-Paymaster, or it may be completed by the Department Adjutant-Paymaster; Det should reimburse Dept Adjutant-Paymaster if she submitted it for you)

*Letters mailed to all dues paying members in June & July informing them that their dues expire August 31. If a member is 1 year and 15 days delinquent, member shall be dropped from the Roster by National and require a new application to renew/reinstate.

*National Convention Delegate Registration Form mailed from detachments that have members attending National Convention

*Annual IRS 990N e-file due after June 30 (up to 5 months after fiscal year expires) All are on July-June FY.

*Paid Life Member (PLM) Audit June 30 on PLM Audit Form, must be submitted to Department Adjutant-Paymaster after it's received in July, but no later than November 30 (ALL Det's are submitted as a group)

*Dues transmittals are submitted when members pay their dues to the Department Paymaster as all dues expire August 31 yearly.

*Detachment Commandant Conference Report to Department due September and January, sent via email to Department Adjutant (Prepared by Commandant, Adjutant-Paymaster, Chaplain, and Chief of Staff as needed)

*Detachment Annual Commandant's Report to Department Commandant and Department Adjutant for Annual Convention should be submitted no later than April 30
