COMMANDANT'S MESSAGE

Marines, FMF Corpsmen, FMF Chaplains and Associate Members. I hope this finds you well. In preparing to travel to the National Convention in Billings Montana to represent each member of this great Department, I was reminded of how an all-volunteer organization such as the Marine Corps League, can be successful. Common courtesy! This courtesy is the only way an organization can continue to grow and operate in harmony with itself. Successful organizations have a chain of command that must be followed to ensure that everyone in the organization is kept informed and no one is caught off guard. Don't be the senior member with a secret. By that I mean there are certain questions that you should ask yourself. What do I know? Who else needs to know? Have I told them yet? I have noticed in several instances of a breakdown of this common courtesy. For instance, a Commandant should know everything that is going on in his Detachment. If someone calls the Adjutant with an idea or a problem, the Adjutant shouldn't try to resolve the problem without first informing the Commandant. The Commandant should then brief his Board of Trustees and together handle the issue. If the Commandant is not informed, then they are caught off guard and this causes resentment and frustration. Always use your Chain of Command correctly. This works the same between the Detachment and the Department. If a Detachment Commandant for advice. If they are not available, then the Sr Vice should be contacted who will in turn use the common courtesy to brief the Commandant. These are just examples. You can insert your own examples but the point that I am making is that if common courtesy is not used, there is a breakdown in communication, and everyone pays the price. The reverse is also true; good communication benefits the Detachment, the membership, and fosters good will, trust, and progress; and, often a better solution can be reached with the contributions of more experienced leadership.

As soon as I return from the National Convention, I will compile all the pertinent information that we collect and report it to you as soon as it is available.

Make Annual Verification of Paid Life Members

Paymaster Patti Leib sends a reminder to all detachments to verify their Paid Life Members (PLM) listed on the Paid Life Member Audit dated 6/30/19 from National. Upon receipt is the best time to do this so it's not forgotten. These are due at National before Dec. 31. If a detachment does not certify its PLM List is true and accurate before the deadline, it will not receive its annual residual interest for its life members. Take the original copy of the PLM Audit and verify the PLM members. **The Commandant and Paymaster must sign** a statement on the original that they certify and annotate that the life member list is audited and is True and Accurate and that there are no changes, or that it is True and Accurate including any changes noted. To make a change, simply line through the incorrect information (so it can still be read) and make a note in the righthand column, stating date of passing of the member. The statement by the Commandant and Paymaster must also be dated. Make a copy for your records after signing and then forward the original to Department Paymaster Patti Leib via US Mail to PO Box 1224, Athens, OH 45701-1224.

National Requires the <u>ORIGINAL</u> signatures, so please send her the original in the mail. She will collect all PLM Audits and send them in a group to the National Adjutant/Paymaster. You must send this signed Audit to Paymaster Leib with enough lead time for her to send it to National and arrive there by Dec. 31. <u>To be on</u> <u>the safe side, she has requested all Detachments send them prior to the September Fall Quarterly Meeting in</u> Logan.

Ref: National Bylaws Sections 645 and 646. The interest paid this year to each detachment was \$1.89 per paid member on your roster as of 9/30/17, which includes the two-year waiting period.

Dues expire August 31

All detachments need to ensure they contact all their dues paying members and encourage them to renew their membership by paying their annual dues on time. Every member in your detachment should be contacted at least once per quarter or more often as necessary. A good way is to stay in touch via the internet by sending out a copy of your meeting minutes and sharing any relevant correspondence that might be important. In addition, the department newsletter has important information about pending meetings and events plus current VA information. Staying in touch with your members via phone calls, letters or personal visits reinforces that they are important members of your unit. Every member is a shareholder of the corporation and is entitled to all rights on an equal basis with every other member. Our members are the lifeblood of the League and we need to take care of them as well as ourselves. We need to extend outreach to the widows and children of our deceased members. This is an excellent source to increase your membership.

Encourage them to join as Associate members because this validates that they are important and it gives them an opportunity to attend events and have some much-needed social activity. They are a valuable resource to the MCL and we need to make them welcome to our events and activities. Help them to honor their loved one by joining in his/her memory.

Annual IRS 990-N

Adjutant-Paymasters: Please Note! It is time for most Detachments to file their IRS 990-N electronically. Only a few detachments are on a calendar year schedule – most are on a Fiscal Year which runs July 1 to June 30 each year. It's a very simple process to go online to <u>www.IRS.gov</u> and in the upper righthand corner under the search feature, enter 990N to access the instructions and online form. There is no fee for this submission, but there is a deadline and if you miss it 3 years in a row, you'll lose your tax-exempt status and it could cost you as much as \$600 to be reinstated. All you need to do is log in, answer a couple of questions, submit your 990-n and print the draft confirmation. After an hour or 2 you can print the page that says your 990-n was accepted; please send me a copy of your confirmation and/or acceptance page. Detachment Administration

Desktop Procedures - Detachments need to maintain copies of National, Department and their own Bylaws and Administrative Procedures. In addition, the following is a guideline for other administrative reports, files and related correspondence that should be maintained for reference.

Detachment Bylaws Department Bylaws with current changes National Bylaws and Administrative Procedures with current changes Guidebook for Detachment Officers Marine Corps League Ritual Charter Articles of Incorporation Permanent Business Certification - Business License West Virginia requires Detachments to have a business license. Effective 2010 all license renewals were issued a permanent license. All non-profit corporations have no fee for their business licenses, although the Annual Corporation Report has a fee of \$26 per year and is due No Later Than June 30th each year!! If you file even one day late, you will incur a \$25 late fee. If your business license has expired and you have not renewed it, contact the WV State Tax Department at 1-800-982-8297 and a renewal form will be mailed to your detachment so you can receive a Permanent Business Certificate. Ensure you have this permanent business license with you anytime you conduct a raffle or a fund raiser. Suggest making a copy of it and covering in a plastic frame or laminate it, and keep your original in your detachment files.

Detachment Filing Procedures (yearly accounts) - Files should be set up according to years. Retain all pertinent files and reports into your yearly folder or large envelope. Example: 2016, 2017, 2018, 2019... These should include: IRS 990 N, Annual Corporate Report, Insurance policy, Financial audits, Property inventory, and Rifle inventory (If you have weapons).

Due to annual files becoming pretty large, you can maintain the Paymaster Reports, Bank Account Statements, Detachment Meeting Minutes, and Annual & Quarterly Reports to the Department, in another file folder or large envelope, again, organized by year. Keep all of these records in a safe, dry location, preferably in a fire proof file cabinet or even a large safe.

Detachment Property Inventory - Should be performed prior to Officer Installation yearly to account for all detachment property.

Financial Records should include:

- (1) Bank Statements
- (2) Financial Audit annual
- (3) Paymaster Reports
- (4) Dues Transmittals
- (5) Transfers
- (6) Paid Life Member Audits
- (7) Quarterly Rosters

Detachment Meeting Minutes - Should be maintained for reference and for any audit from state or IRS as your fund-raising events, donations, and detachment administrative activities are documented.

The Detachment will meet for regular meetings on a scheduled basis on the same day and same time once monthly or as necessary as ordered by the Commandant at a place to be designated. All members will be informed of the meeting date, time and location. Special meetings may be called by the Commandant or by the Board of Trustees upon reasonable notice to the members thereof.

**It is advisable to also keep copies of all your Detachment documents on a couple of flash drives, and share them with your Commandant and maybe your Web Sgt or Sr. Vice, updating them quarterly or at least semiannually. It's best to have this as back up in case of fire or flood or some other problem that could damage or destroy your hard copy files. Keep the flash drives in different locations rather than with your paper files.

Detachment Meetings

The Detachment Commandant is in charge of all meetings and must maintain control of those meetings. Members are reminded that they took an oath to bring no harm to any of the members and that they would follow and obey the rules of the League. All guests including Department, Division or National officers while attending a detachment meeting also follow the same rules as the Detachment Commandant is in charge of his meeting room and has the authority to have the Sgt-at-Arms remove any disgruntled or unruly member from the meeting.

The opening and closing ceremonies will follow the Ritual provided by National Headquarters of the Marine Corps League. The Bible, national insignia, Charter and gavel will always be present. A minimum number of members required to transact the regular and legal business of the Detachment is a quorum. The majority vote of those members present is required to approve general business. Officer meetings require no less than three to conduct business.

The Commandant will have an agenda that indicates the occurring events and reports. The business meeting will be concise, and will serve to inform members of Detachment activities and affairs, and solicit member ideas, information, and response to activities and reports. The meeting will allow time for introduction of guests and new members, induction of new members, and time to welcome new members and introduce all the members. Membership meetings are where members can respectfully voice their thoughts or opinions so any potential conflicts can be calmly and professionally discussed and settled by the members.

The Detachment is a corporate entity and must be run like a business entity with minutes taken to comply with corporate laws. Copies of minutes from all meetings will be kept in the Detachment's permanent files and copies will be sent to the Department Commandant and Department Adjutant. Members through their action and/or verbiage will not do anything detrimental to the good order of a meeting. Committees will meet at time and place deemed necessary and nonmembers will be excluded from meetings when conducting official business.

VA MISSION Act: Answers to the top five questions about Urgent Care

Urgent Care is one of the new benefits offered as part of the VA MISSION Act that gives Veterans greater choice in their health care. This benefit is offered in addition to the opportunity to receive care from a VA provider, as VA also offers same-day services. We are working to ensure Veterans understand how to use the new Urgent Care benefit as part of VA's comprehensive benefits package. In this article, we answer some common questions about the new Urgent Care benefit.

- 1. What is Urgent Care? Urgent Care is a type of walk-in health care for situations where you need help but don't have an emergency, such as colds, ear infections, minor injuries, pink eye, skin infections, and strep throat.
- 2. Why are there different Urgent Care locations? There are two types of Urgent Care network locations: Retail and Urgent.
- Retail Care locations such as CVS or Walgreens are places where you can get care for minor ailments like a sore throat or earache.
- Urgent Care locations provide more comprehensive walk-in care for illnesses or injuries that are not life-threatening, like splinting, casting, lacerations, or wound treatment.

Both Retail Care and Urgent Care locations are staffed with healthcare professionals who are licensed and credentialed.

- 3. Are there Urgent Care providers near me? VA launched the Urgent Care benefit on June 6, 2019, and we are working to expand our network of Urgent Care providers, adding more every week. Urgent Care providers are vetted and must meet strict standards of care and other requirements before they are added to VA's network. To find a location, use the VA facility locator at https://www.va.gov/find-locations/. Select the link entitled "Find VA approved Urgent Care locations and pharmacies near you". If you arrive at an Urgent Care network location and have difficulty receiving care, call 866-620-2071 for assistance and more information.
- 4. How do I get prescription medication with the Urgent Care benefit? You can get up to a 14-day supply of prescription medication through VA, a VA-contracted pharmacy, or a non-contracted pharmacy. If you choose to fill an Urgent Care prescription at a non-contracted pharmacy, you will be required to pay for the prescription when you pick it up and then file a claim for reimbursement at your local VA medical facility. Prescription medication for longer than a 14-day supply must be filled by a VA pharmacy.
- 5. **Do I have to make co-payments for Urgent Care?** Co-payments for Urgent Care depend on your assigned priority group and the number of times you visit any Urgent Care provider in a calendar year. Urgent Care co-payments are not charged when you receive care from an Urgent Care provider, but are billed separately by the VA.

Purple Heart Award: What It Is and Why It Is Awarded

The Purple Heart is a US military decoration awarded to those wounded or killed while serving, on or after April 5, 1917, with the US military. With its forerunner, the Badge of Military Merit, which took the form of a heart made of purple cloth, the Purple Heart is the oldest military award still given to U.S. military members. The original Purple Heart (i.e. Badge of Military Merit) was established by George Washington – then the commander-in-chief of the Continental Army – on August 7, 1782. The Badge of Military Merit was only awarded to three Revolutionary War soldiers by General George Washington himself. General Washington authorized his subordinate officers to issue Badges of Merit as appropriate. From then on, as its legend grew, so did its appearance. Although never abolished, the award of the badge was not proposed again officially until after WWI.

Today the Purple Heart is awarded in the name of the President of the United States to any member of the Armed Forces of the US who, while serving under competent authority in any capacity with one of the US Armed Services after April 5, 1917, has been wounded or killed. Specific examples of services which warrant the Purple Heart include:

a) Any action against an enemy of the United States;

b) Any action with an opposing armed force of a foreign country in which the Armed Forces of the United States are or have been engaged;

c) While serving with friendly foreign forces engaged in an armed conflict against an opposing armed force in which the United States is not a belligerent party;

d) As a result of an act of any such enemy or opposing armed forces;

e) As a result of an act of any hostile foreign force.

The Purple Heart differs from most other decorations in that an individual is not "recommended" for the decoration; rather he or she is entitled to it upon meeting specific criteria. A Purple Heart is awarded for the first wound suffered under conditions indicated above, but for each subsequent award an oak leaf cluster or 5/16-inch star (device) is worn in lieu of another medal. Not more than one award will be made for more than one wound or injury received at the same instant.

A "wound" is defined as an injury to any part of the body from an outside force or agent sustained under one or more of the conditions listed above. A physical lesion is not required; however, the wound for which the award is made must have required treatment by a medical officer and records of medical treatment for wounds or injuries received in action must have been made a matter of official record. When contemplating an award of this decoration, the key issue that commanders must take into consideration is the degree to which the enemy caused the injury. The fact that the proposed recipient was participating in direct or indirect combat operations is a necessary prerequisite but is not sole justification for award. The Purple Heart is not awarded for non-combat injuries.

-VA Income Limits: Calculating Income for Benefit's Eligibility

What some veterans and family members don't know is that all non-reimbursed medical costs are deductible in calculating their income. For example, for veterans who served during wartime and later became disabled and require aid either at home or in an institution, the VA can provide a pension supplement to bring net annual income up to \$20,795 for a single veteran or \$24,652 for a veteran and spouse.

Non-Service-Connected Pension: If you are a veteran who is 65 years-old and older, or permanently and totally disabled you may be eligible for the VA Non-Service-Connected Disability Pension (NSC). The VA NSC pension is a program that provides financial support to wartime veterans with a limited income. The amount payable under this program depends on the type and amount of income the veteran and his/her family members receive from other sources. Monthly payments are made to bring a veteran's total annual income (including other retirement and Social Security income) to an established level.

You may be eligible for the NSC pension if you were discharged from service under other than dishonorable

conditions, and you served 90 days or more of active duty with at least 1 day during a period of war time*, and your countable family income is below a yearly limit set by law, and you are permanently and totally disabled, OR you are age 65 or older. See a Veterans Service Officer for more details.

*Note: Anyone who enlists after September 7, 1980, generally must have served at least 24 months or the full period for which called or ordered to active duty. Service from August 2, 1990 to present is considered to be a period of war (Gulf War) in addition to other periods of war such as World War II, Korea, and Vietnam.

Calculating Survivors Pension You may be able to get this benefit if you haven't remarried after the Veteran's death, if the deceased Veteran didn't receive a dishonorable discharge, and if the Veteran's service meets at least one of the requirements listed below.

**At least one of these must be true. The Veteran: 1) Entered active duty on or before September 7, 1980, and served at least 90 days on active military service, with at least 1 day during a wartime period, or 2) Entered active duty after September 7, 1980, and served at least 24 months or the full period for which they were called or ordered to active duty (with some exceptions), with at least 1 day during a wartime period or 3) Was an officer and started on active duty after October 16, 1981, and hadn't previously served on active duty for at least 24 months

***And this must be true for you: Your yearly family income and net worth meet certain limits set by Congress. Your net worth equals the value of everything you own (except your house, your car, and most home furnishings), minus any debt you owe.

As of DEC 2018: the maximum survivor's pension (assuming you had no income) you could receive is \$9,078 without any children and \$11,881 with one child. Your net worth cannot exceed \$127, 061. Unsuspecting survivors often experience shock and disappointment when they realize how much money the VA Survivor Pension actually pays

VA Agent Orange Claims: VA's Plan to Provide Benefits to Those Eligible

The U.S. Department of Veterans Affairs (VA) is preparing to process Agent Orange exposure claims for "Blue Water Navy" Veterans who served offshore of the Republic of Vietnam between Jan. 9, 1962, and May 7, 1975. These Veterans may be eligible for presumption of herbicide exposure through Public Law 116-23, Blue Water Navy Vietnam Veterans Act of 2019, which was signed into law June 25, 2019, and goes into effect Jan. 1, 2020.

They may also qualify for a presumption of service connection if they have a disease that is recognized as being associated with herbicide exposure. The bipartisan Blue Water Navy Vietnam Veterans Act gives VA until Jan. 1, 2020, to begin deciding Blue Water Navy related claims. By staying claims decisions until that date, VA is complying with the law that Congress wrote and passed. "VA is dedicated to ensuring that all Veterans receive the benefits they have earned," said VA Secretary Robert Wilkie. "We are working to ensure that we have the proper resources in place to meet the needs of our Blue Water Veteran community and minimize the impact on all Veterans filing for disability compensation."

Blue Water Navy Veterans are encouraged to submit disability compensation claims for conditions presumed to be related to Agent Orange exposure. Veterans over age 85 or with life-threatening illnesses will have priority in claims processing. Veterans who previously were denied for an Agent Orange related presumptive condition can file a new claim based on the change in law. Eligible survivors of deceased Blue Water Navy Veterans also may benefit from the new law and may file claims for benefits based on the Veterans' service.

The new law affects Veterans who served on a vessel operating not more than 12 nautical miles seaward from the demarcation line of the waters of Vietnam and Cambodia, as defined in Public Law 116-23. An estimated 420,000 to 560,000 Vietnam- era Veterans may be considered Blue Water Navy Veterans. To qualify, under the new law, these Veterans must have a disease associated with herbicide exposure, as listed in 38 Code of Federal Regulations section 3.309(e). Agent Orange presumptive conditions are:

• AL amyloidosis Chloracne or similar acne form disease,

- Chronic B-cell leukemias,
- Diabetes mellitus Type 2,
- Hodgkin lymphoma, formerly known as Hodgkin's disease,
- Ischemic heart disease,
- Multiple myeloma Non-Hodgkin lymphoma, formerly known as Non-Hodgkin's lymphoma,
- Parkinson's disease,
- Peripheral neuropathy,
- early-onset Porphyria cutanea tarda,
- Prostate cancer,
- Respiratory cancers (lung, bronchus, larynx or trachea), and
- Soft-tissue sarcoma (other than osteosarcoma, chondrosarcoma, Kaposi's sarcoma or mesothelioma).

The Civilian Health and Medical Program of the <u>Department of Veterans Affairs</u> (CHAMPVA) is a health benefits program in which the VA pays part of the cost of certain health care services and supplies. The program is available to:

The spouse or child of a veteran who has been rated permanently and totally disabled for a service-connected disability by the VA.

1. The surviving spouse or child of a veteran who died from a VA-rated service- connected disability. 2. The surviving spouse or child of a veteran who was rated permanently and totally disabled at the time of death.

3. The surviving spouse or child of a military member who died in the line of duty, not due to misconduct. (In most of these cases, these family members are eligible for Tricare, not CHAMPVA.)

Like most insurance plans, you can get your prescriptions filled at a local pharmacy or through the provider's mail-order pharmacy. Effective immediately, CHAMPVA recipients can also use the My HealtheVet site in addition to the other two options.

Using HealtheVet adds a level of convenience to filling and renewing prescriptions. You are able to refill, review and track your prescriptions online using your computer or smart phone. You also have a record of all medications you are taking available at your fingertips. You can still get your urgent medications filled at your local pharmacy, but getting long- term or maintenance medications via the My HealtheVet website is faster and easier than using the mail-order pharmacy.

CHARLESTON, W.Va. — Officials at the Charleston, West Virginia, airport have unveiled a new armed forces operations center named after the state's last surviving Marine Corps Medal of Honor recipient from World War II. The 2,000-square-foot facility at Yeager Airport was named in honor of Barboursville resident Hershel "Woody" Williams on Friday. Williams was awarded his medal for heroic actions at Iwo Jima in 1945. The Herald-Dispatch reports that Williams wiped tears from his eyes during the dedication as he learned of the surprise gesture. The Woody Williams Military Flight Operations Center is on the grounds of Yeager's general aviation area. It will be used for training missions in the area. Airport Assistant Director Nick Keller told the paper 67 military units have based training operations or make fueling stops at Yeager.

Q&A with Marine flame-throwing war hero on ship naming, his new mission

Hershel "Woody" Williams Medal of Honor Foundation, which encourages, with the assistance of the American public and community leaders, establishing permanent gold star family memorial monuments in their communities throughout the United States to honor gold star families who have sacrificed a loved one in the service of their country.

The last surviving Marine Medal of Honor recipient from the World War II Battle of Iwo Jima is about to have a Navy ship named for him. And while the ship will enable Marines and sailors to carry out new missions around the world, Hershel "Woody" Williams is setting out to complete one of his own — to get a Gold Star monument built in all 50 states.

Williams will become the namesake of the Navy's newest expeditionary-sea-base ship, Navy Secretary Ray Mabus formally announced at a ceremony in Charleston, West Virginia, earlier this month.

The Navy named the vessel, slated for delivery in 2018, for the 92-year-old war hero at the prompting of Sen. Joe Manchin, D-W.Va., and after an 18-year campaign by Ron Wroblewski, president of the West Virginia Marine Corps Coordinating Council.

On Feb. 23, 1945, over a four-hour period in the struggle for the 8 square mile island, Williams took out a network of enemy defensive positions holding up his 3rd Marine Division's advance — with a flamethrower. President Harry S. Truman personally awarded Williams the nation's highest military honor on Oct. 5, 1945, for his valor above and beyond the call of duty.

"Quick to volunteer his services when our tanks were maneuvering vainly to open a lane for the infantry through a network of reinforced concrete pillboxes, buried mines and black, volcanic sands, Corporal Williams daringly went forward alone to attempt the reduction of devastating machine-gun fire from the unyielding positions," his Medal of Honor citation reads.

Williams continued to serve in the Marines after the war until 1963, when he retired as a chief warrant officer four. He then continued in public service for a further 35 years with the Veterans Affairs Administration. In 2012, he established the Hershel Woody Williams Medal of Honor Foundation, a charitable non-profit through which he is seeking to establish Gold Star Family memorials in all 50 states to honor the families of the fallen.

Marine Corps Times recently caught up with Williams to talk about that mission, and how he hopes his legacy will continue to live on through sailors and Marines aboard the new vessel named for him.

Q. What does it mean to have a ship named after you?

A. Well, others made it possible for it to be named for me. Secretary Mabus asked me the same thing. When you name something after someone, it means they're dead. They named it for me. I'm still living, and I'm not going anywhere.

Why would I, as a country boy from West Virginia, have a U.S. Navy ship named after me? The only reason is that others made it possible.

So I accept it as an honor on their behalf, not mine; it makes me very humble. I'm still trying to comprehend its meaning to my family to have my name on it. There's no way I could ever adequately express appreciation for what this country has done on my behalf.

Q. How do you hope this will help carry forward your legacy?

A. I'm not a predictor of the future, except for years there might be those who inquire and wonder who this ship is named after. Who was it that merited this honor? What's his story? I don't know the answer.

Q. Why did your senator push for this to happen?

A. First, you have to remember the name of the Marine Ronald Wroblewski, a Vietnam veteran who started this project in 1997. He had been through Norfolk and saw a ship being named after a Medal of Honor recipient. He knew there was a Medal of Honor recipient living back home in West Virginia, so why not do it for a living one?

I told him, "I'm not dead, so stop wasting your time." But he didn't, and by 2005 or 2006 he had submitted some 70,000 documents — signatures, resolutions, and the like — to the U.S. Navy. The Navy said it was the largest file they ever had to name a ship after someone.

My grandson, Brent Casey, a Desert Storm veteran, was familiar with what Wroblewski was doing. We went to Iwo Jima for the 70th anniversary of the battle. Secretary Mabus was there so Brent asked him about it. Secretary Mabus looked into it and said the reason nothing ever happened was there was no ship to name and no authority to name one after someone living. Brent then asked Senator Manchin about it and he agreed to send a letter to Secretary Mabus, who worked to change the rules so a ship could be named for someone living.

Q. You're now working to establish Gold Star family memorials in all 50 states. Why is that such an important project for you?

A. Many Gold Star families have never been recognized. People don't really know what a "Gold Star Dad" is. We as a country have done a pretty good job recognizing Gold Star Mothers, but other family members haven't always been recognized.

When you lose a family member, everyone pays a price, everyone grieves. For many of them, these memorials are the first time in many years anyone has ever said, "Thank you for sacrifice you made when you lost a loved one."

Q. What is the goal of that project?

A. We set up the foundation in 2012 with the idea of having a memorial in each state. In 2013, we had the first dedication in West Virginia, the first in the U.S.

We needed a specific goal for the foundation, so we decided to try to have at least one in every state. We changed the wording to at least one so there'd be no limitations. Now in West Virginia we have three; Kentucky will have three and California, Texas and Ohio will have two.

The goal: Whatever it takes for our communities to be able to honor our Gold Star families, that's what they should do. There are about eight completed memorials in six states and 18 more memorials at different stages of completion.

Q. Today's generation of Marines still read your Medal of Honor citation and learn about what you did that day so many decades ago. What do you recall most about the day you earned your MOH?

A. I can't say with certainty that one moment stands out above the rest, but if I had to choose, it was the moment the Japanese came charging out of their pillbox with their rifles, with bayonets fixed, toward me. Fortunately, I still had fuel in the flamethrower and was able to get the igniter to work to set the fuel on fire. I just got them before they got me.

Q. What do you hope young Marines take away when they read that citation and hear about your story?

A. The best advice I'd give is to pay attention to every detail, because you never know what the circumstances will be that your life will depend on something you thought at the moment would never impact you. Learn everything about your job so you'll be prepared should the unexpected happen.

On Feb. 23, 1945, it wasn't my job to know how a flamethrower works. My job was to make sure those guys had the gear and fuel they needed. But when it got around to me, there was no one left and I had to do it.
