### Welcome to all Marines, FMF Corpsmen, FMF Chaplains and Associate Members:

Another month has passed and we are still under the Covid-19 virus. The only change is the spread seems to have gotten worse recently.

The Department Adjutant/Paymaster Patti Leib and I went to the Capital Bldg. in Charleston to pick up a check from the assistant Chief of Staff to Governor Justice. The Governor has given all of the Veterans organizations in the state \$5,000 to help with their financial situation since they are unable to do fundraisers due to Covid-19. The Department of WV MCL received \$105,000. This covers \$5,000 to each of our 14 Detachments plus the Department, 5 MODD Pounds and 1 MODD Pack. This is a tremendous boost to all of our members and will help keep us afloat in the coming year. Use it wisely as we don't know what the virus will do in 2021. We still have some Detachments skating on thin ice with low membership numbers. Remember all membership dues are due by August 31 and on September 1<sup>st</sup> those members who have not paid their dues are in arrears and therefore are not covered by the National Insurance policy.

This past Friday evening, I participated in a Mideast Conference call with MED National Vice Commandant Roger Ware, Mideast Adjutant Frank Mathers, the Commandant of Delaware as well as the Commandant of Virginia Dave Glasgow, Earl Ruff Commandant of Maryland, Patti Leib Adjutant/Paymaster of West Virginia, Jerry Bain Senior Vice of West Virginia and several other participants. Various subjects were discussed such as:

- 1) how Detachments are required to send their bank account numbers and their routing numbers through their Department Adjutant-Paymasters so they can submit them to National. This will allow National to disburse the Paid Life Member interest to each Detachment's bank accounts electronically.
- 2) Detachment Judge Advocates must go through their Department Judge Advocate on issues that arise, and the Department Judge Advocate needs to go through the Division Judge Advocate rather than directly contacting the National Judge Advocate.
- 3) If the Detachment ROI's (Report of Officer Installation) are not sent in on time then the Detachment is not covered by the National Insurance policy until this is done.
- 4) The PLM Audit page sent to each Detachment needs to be examined and audited to assure that all members listed are alive; the Commandant and Paymaster must sign the Audit and send it to the Department Paymaster.
- 5) Annual Corporate reports must be updated each year on the Secretary of State of West Virginia website. A copy of the confirmation page needs to be submitted to the Department Paymaster.
- 6) An annual IRS990N must also be completed online within 5 months after the end of your fiscal year. Contact Adjutant-Paymaster Leib if you need assistance; she submits 990's and Annual Corporation Reports for several Detachments yours may already be on her list, but if you'd like for her to do yours, please let her know.
- 7) Not submitting either of these items (ACR and IRS990N) can cause your Detachment to lose your Tax-Exempt Status or ability to conduct business in the State of WV. Do Not Delay in complying!

Don't forget the Quarterly Meeting January 16 at the American Legion Post 23 in Point Pleasant hosted by MGM Detachment 1180. Meeting starts at 10:00 hours with the Department Officers meeting at 9:30 hours. The ladies of the Detachment prepare an excellent meal.

Please keep all members of our Armed Forces in your thoughts and prayers as they serve in harm's way.

### MAJOR GENERAL JOHN A. LEJEUNE'S BIRTHDAY MESSAGE

On November 1st, 1921, John A. Lejeune, 13th Commandant of the Marine Corps, directed that a reminder of the honorable service of the Corps be published by every command, to all Marines throughout the globe, on the Birthday of the Corps. Since that day, Marines have continued to distinguish themselves on many battlefields and foreign shores, in war and peace. On this Birthday of the Corps, therefore, in compliance with the will of the 13th Commandant, Article 38, United States Marine Corps Manual, Edition of 1921, is published as follows:

"(1) On November 10, 1775, a Corps of Marines was created by a resolution of the Continental Congress. Since that date many thousands of men have borne that name Marine. In memory of them it is fitting that we who are Marines should commemorate the Birthday of our Corps by calling to mind the glories of its long and illustrious history.

The record of our Corps is one which bear comparison with that of the most famous military organizations in the world's history. During 90 of the 146 years of its existence the Marine Corps has been in action against the Nation's foes. From the Battle of Trenton to the Argonne, Marines have won foremost honors in war and in the long eras of tranquility at home, generation after generation of Marines have grown gray in war in both hemispheres, and in every corner of the seven seas so that our country and its citizens might enjoy peace and security.

In every battle and skirmish since the Birth of the Corps, Marines have acquitted themselves with the greatest distinction, winning new honors on each occasion until the term "Marine" has come to signify all that is highest in military efficiency and soldierly virtue.

This high name of distinction and soldierly repute we who are Marines today have received from those who preceded us in the Corps. With it we also received from them the eternal spirit which has animated our Corps from generation and has long been the distinguishing mark of Marines in every age. So long as that spirit continues to flourish Marines will be found equal to every emergency in the future as they have been in the past, and the men of our nation will regard us as worthy successors to the long line of illustrious men who have served as "Soldiers of the Sea" since the founding of the Corps."

### **Recruiting and Retention**

It's a typical stereotype image associated in locations where veterans gather: a place to retreat and share kinship with men who became close because they stood side by side in conflicts like the *Vietnam War*, or met in veteran outreach programs.

But it's not the image the next generation of vets wants people to think of. As we attempt to change the image that most older veterans portray younger veterans indicate it's time to go back to a grassroots campaign of family-oriented programs and community service.

The Marine Corps League, like the military itself, must shift and offer more personalized, tailored positions that give prospective members or those thinking of leaving the Marine Corps League a sense of purpose and belonging.

At some point in time, the MCL and other legacy service organizations, switched from being a community-centered focal point to being an exclusive social club. And that is switching back.

Post-9/11 vets find themselves more closely aligned to the League's founders, the *World War I* era service members who were on a mission to give back to communities, build partnerships with local and state organizations and foster programs geared toward camaraderie and family events.

While the League has always maintained a responsibility to its purposes, those efforts at some point became less prominent. The image of a bunch of old guys sitting around complaining about the VA and swapping war stories was born.

They're fighting against their own perception of what the MCL is because the MCL is not a bar and they're fighting against the public perception because that's all they've done for the last several decades. There's most positive growth across the country in communities where the members are active and gaining exposure. Participating in numerous military themed events and civic activities is a huge aid in recruiting more members.

While old members are dying off, the young Marines aren't interested, as the Marine Corps League has lost its appeal. Acknowledging there has been the long-standing stigma of WWII Veterans verses Vietnam and today's Veteran, we need to close this gap because each vet has something different to offer either to their Detachment or to his or her community.

Standing up a new detachment is especially promising because they offer a fresh start and can be whatever they want to be. A lot of people think that they have to have a building. You can do it anywhere, really. Your home, a local community facility, a room at the library, a Denny's or Golden Corral, a classroom at the school, shelter house at a park (during good weather) — most anywhere just have to have a place to host your meetings. It could be a virtual community through online video conferencing. It could be via face book or other social media. Many Detachments have had to resort to virtual meetings during the pandemic, so meeting in person each and every month is not mandatory; our electronic age can fulfill the meeting requirements quite well.

There is a larger, long-term strategy to bringing in new members and the MCL is long overdue to incorporate more targeted conversations and marketing efforts to recruit and retain members. The MCL needs to capitalize on the talents of the people that we're recruiting.

The recruitment conversation can come down to picking a demographic, and it comes down to a question of, for lack of a better word, talent management and engagement.

The Defense Department has moved toward tailored messaging to a generation skeptical of service. The League have a struggle with talent management, where we have people that want to come in and do good work, they want to continue serving, but we haven't trained ourselves as an organization to identify and put those people in the right position.

Retention is also a huge problem for similar reasons. If you don't capitalize on the skill set or the interest of the veteran, they're not going to renew. They won't want to come back. They can't get what they are looking for out of this organization, which we should be offering.

You have to ensure that you're providing something that is satisfying for all the members of your detachments across all demographics and generations. You really have to re-inflate that sense of purpose and direction so people know that what they're doing is making a difference. We have to engage them and get them into a committee where they are productive.

One main reason many of the younger Marines do not join is because they have a family and there's a need to share time with them. The department had been going through a tough phase, but reinvigorating family time cookouts, fairs, and a little something for everyone became the catalyst it needed. The family is important and doing things where they can interact helps them see the benefit of belonging and helps fulfill the social aspect. It's also about the outreach work within our mission of taking care of veterans and their families, widows and orphans and strengthening our community. When we do events and activities where our members physically participate, it helps bond them to our League and the community.

# Thirteen missing children found in West Virginia

**CHARLESTON, W.Va**. — A joint operation by the U.S. Marshal service in the southern district of West Virginia and the southern district of Ohio netted the location of 45 missing children. Thirteen of those missing children were found in West Virginia as part of what was called Operation Autumn Hope.

U.S. Marshal for the Southern District West Virginia Mike Baylous said his office joined the operation in neighboring Ohio to increase the size and scope of the operation.

"We had a few, but we also had leads from other states. We decided instead of having our own operation down the road, since we are a small district, we would just with southern Ohio. It was very successful," Baylous said Wednesday on MetroNews "Talkline."

The 13 children discovered in West Virginia included three reported missing in San Bernardino, California who were located in Beckley. They had been taken in a parental dispute. Three other children, located in Jackson County, were reported missing form Ohio. One child missing form Richmond, Va. was located in Princeton.

According to information released by the Marshal Service, three children who had been reported missing in Lawrence County, Ohio were also found in Lawrence County, Ohio. There were also three children missing from southern West Virginia. Two of those children were located in Kanawha and Putnam counties. The third child was found in Princeton and in that case had been missing for less than six hours.

"Some of them were runaways. A lot of them tend to be a domestic situation where a parent or relative kidnaps them and some of them are kidnapped by strangers.

Baylous credited the numerous small police departments and other small law enforcement agencies which worked together as part of the CUFFED task force and helped with details on the investigations.

"U.S. Marshal Service has been the experts since 1789 when it comes to tracking people downs," Baylous said. "They think coming into rural West Virginia they're going to be able to hide out. That may work for a little while, but West Virginians know their neighbors and when we see something suspicious, we're going to report it to authorities."

## Whitmer Bridge Renamed for Korean War Vet

Elkins Marine Corps League Detachment 956 Commandant Roger Ware, foreground, and Past Detachment Commandant Greg Irwin, background, fold an American flag during a ceremony Saturday to rename the new Whitmer bridge in memory of U.S. Army Sgt. James Shellace Armentrout. Armentrout, a member of Company K, 3rd Battalion, 23rd Infantry Regiment, 2nd Infantry Division, was 20 years old when he was listed as missing in action on May 18, 1951, following combat action in Hangye, South Korea. On Dec. 31, 1953, he was declared as presumed dead. The bridge dedication also featured the Missing Man Table Ceremony, in which a small table with a setting for one symbolizes the absence of a service member who is a prisoner of war or is missing in action and cannot be in the company of family and friends. A sixth-grade student's research project about her ancestor declared missing in action during the Korean War was the catalyst for efforts to rename the new Whitmer bridge in the soldier's memory

### **Mideast Division Marine of the Year**

Section 300 (h) of the National Administrative Procedures outlines the criteria for selection of the National Marine of the Year. Using these provisions, the following Mideast Division MOY recipients are the committee to select a 2021 Mideast Division Marine of the Year. The Chairman is Frank Mathers - Department of Delaware. The other committee members are: Bud

Raines - Department of Maryland, Richard Tanner - Department of Delaware, Roger Ware,

Mike McLain and Rick Shank - Department of West Virginia and Jeffrey Jones and Rick Thomason - Department of North Carolina. The guidelines in Section 300 (h) (2) of the above reference must be followed for each nomination. Please insert "Division" in lieu of "National ", as appropriate. Any regular member from the Mideast Division can be nominated and the Mideast Division MOY will be presented at the 2021 Mideast Division Conference, April 17, 2021 in Rehoboth Beach, Delaware. Each letter of nomination must be mailed to the above chairman, registered return receipt, post marked not later than March 17, 2021. Mail to Frank Mathers, Mideast Division Chairperson Marine of the Year Committee, 17 Fairway Drive, Ocean View, Delaware 18870. Telephone: 301-520-8051. It must have a cover letter signed by the Commandant and Adjutant or other officers if one of them is nominated. An inner envelope must be addressed to the Mideast Division Chairperson Marine of the Year Committee. A second envelope must be addressed to the Chairperson. It must be sent Certified, Return Receipt Requested for your records, before the postmark deadline. The Marine of the Year Committee will announce the 2021 recipient during the Mideast Division Conference. The above provisions are for 2021 Marine of the Year selection only.

### **Division Marine of the Year Criteria**

This award shall be presented to a REGULAR MEMBER of the Marine Corps League who has rendered service(s) and/or performed a deed(s) above and beyond the duties and obligations required of a member of the Marine Corps League, or a meritorious deed(s) so identified as being within the scope of these rules shall be of such substance that the weight will or shall have brought acclaim and prestige to the Marine Corps League; or has enhanced and/or furthered the concepts of the duties of being a citizen of the United States of America; or a deed(s) of courage or valor without regard for his/her own safety

Letters of nomination must originate only at the DETACHMENT LEVEL. No individual nor any subsidiary unit of the Marine Corps League shall submit a letter of nomination.

All letters of nomination shall include a letter signed by the Detachment Commandant and Adjutant, stating that the nominee for Division Marine of the Year was approved at a regular meeting of the detachment by a majority vote. (In the event a nominee is the Commandant, the letter of nomination shall be signed by the Senior Vice Commandant and the Adjutant. In the event a nominee is the Detachment Adjutant, the letter of nomination shall be signed by the Detachment Commandant and Senior Vice Commandant).

Each nomination submitted shall be placed in a sealed envelope and addressed to "Chairperson, Division Marine of the Year Society". THIS ENVELOPE SHALL THEN BE PLACED IN ANOTHER ENVELOPE and mailed, certified/return receipt requested, to: The Chairman at the address listed on the announcement.

The member must be a member in good standing and have served at least either an elected or appointed position within his detachment and department. List how many years he has been a member. List his positions and what was the significance of each if any. Is he a Detachment or Department Marine of the Year?

The recommendation should summarize what the member has done in his detachment, and or department. It should be brief and only impact areas where the candidate performed that brought credit upon his detachment and not merely list that he performed the duties expected of his position and or attended meetings. What were the results of any activities he participated in that were above the normal expected duties of his position?

List those activities where he was the chairman or committee lead. Examples: Toys for Tots for 15 years and how many toys collected and how many children benefited. Chairman of numerous fund-raising events that benefited detachment or selected charities. What was the total amount generated? Did he teach flag etiquette or flag folding to children, how many classes and how many kids for how many years.

What civic projects or volunteer did he do to enhance the league. If he did not participate as a league member in an event or activity, do not list it. What did he do as a volunteer outside of his detachment for the league? Was he recognized within his community for a project?

The nomination should be a snapshot of the member's achievements and not just listing his MCL awards. Did he attend his department quarterly meetings or convention, Mideast Division Conference, National Mid-Winter Staff Conference, National Convention?

The Division MOY Committee has developed a point system to aid them in their selection process. Consideration can be giving a point for each event, and a point giving for participation outside his detachment for either serving on department, division or national level and on any committee.
