#### **Professional Development Training**

#### **Detachment Administration**

Once the installation is performed, the new Officers need to hold a meeting of all officers. This is a good time to review the administrative duties required to ensure your detachment functions as a business entity. The duties of all Officers should be discussed and what their role is in the detachment. The financial records should be reviewed as well as the property inventory. The Adjutant should have copies of all previous minutes and any pertinent correspondence and files including copies of the Charter, all Bylaws and AP, corporate papers, business certificate, annual corporate reports, IRS 990 N e-files, Officer installations reports (ROI), PLM audits, Ceremonial rifle inspection and audit (those having rifles) and resolutions. The Paymaster should have all the financial records and bank account statements, checks, and previous paymaster reports. Ensure you sign new bank signature cards for the Commandant and Paymaster or Adjutant/Paymaster. Copies of all previous dues transmittals should be maintained. The Sgt-at-Arms should have all flags, banners, and ritual items in his possession or securely stored at the meeting location.

Once these items are secure and accounted for, then the Officers should look back over the previous Minutes to get an update and include any previous motions that are pending from those minutes. They should plan the agenda for the next meeting and look forward to dates for future activities and events and plan accordingly. Discuss plans for future fund-raising events. Look at all reoccurring reports and ensure they are included in their future meetings. The Adjutant should include them in the monthly meetings minutes and utilize a system ensuring they are completed on schedule and on time. They are in the section below under Required reports following Officer Installation.

Next assign your committee members and ensure all required positions for other assignments are filled. Go over your means to communicate with your members. Set up a free conference call line for this use. The Department Adjutant can help you with this. At your meetings, solicit ideas and brainstorm on how to recruit and retain members. Encourage members to attend the Department meetings and Conventions. Ensure all Officers read the various Bylaws and Administrative Procedures and have a working knowledge of them. Be sure to have all

Officers read over the Guidebook for Detachment Officers and plan out professional development training sessions for your officers and members.

Have a telephone calling tree with phone numbers, emails, and other information so you can communicate with all your members.

Be flexible and don't fret over mistakes you might make as that goes with the position. Make liaison with your Department Officers and utilize them. If you are ever in doubt, make the call and seek advice.

#### **Required reports following Officer Installation**

Following reports are required in this order:

- \* Financial audit and property inventory should be conducted before installation
- \* Report of Officer Installation (ROI) completed and mailed to Dept Adjutant
- \* Letter to Bank to change signature cards adding new Commandant and Paymaster after a motion to make change approved by members.
- \* Annual Corporate Report will be completed after office installed and submitted online to WV Sec of State at cost of \$25.00
- \* Paymaster Report (due each membership meeting)
- \* Copy of Monthly Detachment Minutes must be forwarded to Dept Commandant and Dept Adjutant following every meeting as per Department Bylaws.
- \* Membership update to Dept Jr Vice Commandant Monthly
- \* Quarterly and Annual Commandant's Report from Detachment for ending Quarter (due Sept, January, May) submitted to Dept Adjutant
- \* Letters mailed to all dues paying members beginning in May informing them that their dues expire August 31
- \* National Convention Delegate Registration Form
- \* Annual IRS 990N efile due after June 30 or 5 months after fiscal year expires
- \* Paid Life Member (PLM) Audit June 30 roster
- \* Dues transmittals are submitted when members pay their dues to the Department Paymaster as all dues expire August 31 yearly.
- \* Death notices are filled out and a dues transmittal form coded NOD is sent to the Department Paymaster for submission to National HQ and the Department Chaplain and Assistant Chaplain (the Dept Paymaster will submit them for you)

#### Officer Nominations, Elections, and Installation

The next item for detachment focus is Officer Election and Installation, and completion of the ROI. The ROI is required as this lists the Commandant and Paymaster who handle money and <u>only</u> they are covered under the insurance bond by National. Plus, the ROI has the current email address of your Paymaster so National can send copies of the completed transmittals and other items or communications.

**National no longer mails** the yearly PLM interest payment to your detachment. Instead, the Department Adjutant Paymaster will collect your current Bank Account information (checking account number and routing number) to submit to National so the PLM Interest payment can be deposited directly by ACH. The Department Adjutant-Paymaster will track all Detachment PLM audits and ROI's.

Detachments are required to hold their Elections and Installation of Officers between Sept 1 and May 15 although most Detachments elect their new Officers after January 1. After the Installing Officer signs the ROI, the Detachment Adjutant ensures the information is correct, legible, and completed and then sends it to the Department Adjutant who makes a copy and forwards it to National HQ. The department Adjutant tracks all Detachment reports and submissions to make sure every Detachment is in compliance. #### **Annual Corporate Report**

Every detachment must be incorporated within the State of WV so after your Annual Officer Installations are complete, the Detachment must complete and file a Corporation Annual Report prior to 30 June each year. This is done online with the WV Secretary of State, Business and Licensing Division, and submitted electronically and costs \$25. If Officers are installed or changed after 1 July, the Detachment must file an Application to Appoint or Change Officers, and/or Office Addresses with the WV Secretary of State and pay an additional \$15 to make the change(s). Once this process is completed, a copy of the receipt should be mailed or emailed to the Department Adjutant for record purposes. Every detachment that is incorporated must file an Annual Report for Corporations. This should be done as soon as you have your Officers are Installed. The Secretary of State will no longer accept a paper copy of your ACR. Detachments and Pounds that do not file their annual reports on time are at risk of being administratively dissolved or revoked and will be assessed a mandatory late fee of an additional \$25 (twenty-five dollars) for non-profit organizations as required by West Virginia code.

**Concepts on League memberships** 

The Marine Corps League has been around for almost a century and was created to build a community among Marines who served or have returned from the horrors of war and to:

- a. To preserve the traditions and to promote the interests of the United States Marine Corps.
- b. To band those who are now serving in the United States Marine Corps and those who have been honorably discharged from that service together in fellowship that they may effectively promote the ideals of American freedom and democracy.
- c. To fit its members for duties of citizenship and to encourage them to serve as ably as citizens as they have served the Nation under arms;
- d. To hold sacred the history and memory of the men who have gave their lives to our Nation.
- e. To foster love for the principles which they have supported by blood and valor since the founding of the Republic.
- f. To maintain true allegiance to American Institutions.
- g. To create a bond of comradeship between those in the service and those who have returned to civilian life.
- h. To aid voluntarily and render assistance to all Marines, honorably discharged Marines, FMF Corpsmen and FMF Chaplains, as well as to their families, their widows and their orphans.
- i. To perpetuate the history of the United States Marine Corps by fitting acts, and to observe the anniversaries of historical occasions that are of particular interest to Marines.

The League is a place where the deep bonds begun by serving in the Corps or in foxholes overseas can be woven stronger, where generations have not only healed but chosen to give back to their communities.

As the Iraq and Afghanistan veterans transition back into civilian life and deal with the horrors and side effects of PTSD brought on by multiple tours in combat zones. Several League members that are combat veterans from WW II, Korea and Vietnam know exactly what that feels like.

The League provides the platform for these members as well as Peacetime and Associate members to band together and provide valuable insight to each other from shared life experiences.

When the League gathers together as a unit, we show moral support to each other by being there for one another and taking time to just listen to each other's thoughts and concerns and in turn mental support is achieved to curve the current epidemic of veteran suicide today which is heartbreakingly high due to America's all-volunteer force serving multiple tours in combat zones as well as veterans dealing with problems we have in everyday life that can accrue during or after military service.

Once you find the Marine Corps League and embrace the tribe, you will find that none of us stand alone and the acronym we follow is (T.E.A.M) Together Everyone Achieves More. Semper Fidelis!

Marines that have PTSD have found that joining the League is like joining a hospital as it's therapy, and more than anything, it's family and still a "Band of brothers".

Those stereotypes are those that we continue to combat and it's fair to say that Marines enjoyed going into a bar and swapping war stories, and maybe that was the extent of it. But over the years, Marines' desires just have changed drastically.

The generation of Marines who fought in the post-9/11 wars, have found community in other places, and they often prefer experiences like participating in marathons and going kayaking versus sitting around listening to some older Marines talk about politics.

The League is a lot more aware of its image, and is starting to focus on that image to be sure that members know the League is representative of Marines from every era...

The aging membership rolls continue to lose Marines, and the generation of retired service members from two decades of combat this millennium haven't shown up to fill their shoes.

Are our current members willing to take responsibility to actively seek new and younger members, like recruiters for the USMC, to help secure the future of the Marine Corps League, and to assist the younger generation with successfully transitioning and acclimating back into civilian life? It's not only important to the future of our League, but also young Marine families, and the future of our Country.

Our League has a lot to offer besides renewing the camaraderie shared while serving on active duty. We have members who can help with VA claims, others who can help network for employment, funds for Marines in distress, scholarships for education, community and civic involvement for students, fund raising activities to benefit school sports programs, participation in various military themed and patriotic events, disaster assistance and lobbying for medical and additional benefits for Marines. These are just a few things our League supports so are you ready to get on board and come join our league and share your vision and ideas?

#### **Recruitment of younger Marine Corps members**

Military veterans by participating in a veterans organization provides a unique opportunity to serve in their community with people from all walks of life, and also offers the opportunity to share the bond and camaraderie that melds veterans together as proud United States Marines.

Far too often, detachments are standing by and waiting for this younger generation of Marines to just walk in and join like their fathers and grandfathers before them. This used to be the marketing strategy to bolster membership in the League. The League has relied solely on our name to entice these young Marines to show up and join, and most Detachments have a marketing campaign that hasn't quite made it into the 21st Century. It may be sending

an application for them to complete and asking for money and not enclosing an information page. You need to be aggressive and seek them out. Go to high traffic areas, set up a booth or table and sell the League.

How do we get the younger Marines to be part of that? The answer is we don't. The League must change. The thought that eventually the younger Marines will join because they are missing the camaraderie is a false notion. There are too many newer and younger Veteran Organizations that have popped-up in the recent years for them to join, leaving a vast number of veteran organizations competing for membership from a much smaller pool of veterans.

The League might use the following common-sense steps to appeal to that younger generation of Marines who are the very life-blood of the existing MCL to build more memberships

- 1. Be honest and transparent when sending out material to attract new members. Educate the younger Veteran generation by conveying to them all you have accomplished locally and nationally to ensure that Veteran issues stay at the forefront of the discussion. Show them that you are making a difference. Let them know about the whole League and not just your Detachment, and that it's not just a narrow scope of membership and money.
- 2. Treat all Marine veterans equally. Both men and women have served honorably in the Marine Corps. To assume only men deployed or served is backwards thinking and has no room in today's Marine Corps League.
- 3. I know the more seasoned Marine veterans have life experience and perhaps a different frame of reference. But we should never think that the younger generation is any different. As leaders, we should always welcome new ideas from everyone, and the younger veterans are full of ideas-just as we were at that age. You should embrace their energy and let them share their ideas about improving your detachment; you will be pleasantly surprised with the innovative ideas that they come up with. Be open to these new ideas.
- 4. Welcome all Marines into your detachments. When you see someone new walk in, welcome them with open arms, make them feel like they are part of your detachment and have found a new family and friends. And don't criticize the way they look now or their time in service.
- 5. Keep your meetings short and to the point. If you have younger Veterans in your detachments, assign them a task during the meeting and ask them to work with the membership to complete it. Get them involved in the administration of your detachment and encourage their involvement. The younger generation, especially the millennial's like to solve problems by working and teaming with a group. This is a prime opportunity for the detachment leadership to mentor those younger Marines. Be patient. Some of these young Marine veterans suffer from a malady of challenges, such as Traumatic Brain Injury or PTSD
- 6. Use your detachment as a place where veterans can network with the community. Invite local business owners, company executives, your local college Veteran's Representatives, or members of the local Chamber of Commerce to speak at your meetings.
- 7. Don't be afraid to work with other Veteran organizations within your community. Build a strong support network for all Veterans.
- 8. If you have a reserve unit or National Guard unit nearby, begin working with them to build a relationship. These once flourishing programs have had their share of budget cuts, but the mission remains the same. This is where the Marine Corps League could make a positive impact with the base leadership as well as the surrounding veteran population.
- 9. Introduce yourself and your detachment to your local Guard and Reserve centers. Most of the members live, work, and shop in your community.
- 10. Sign up for and attend every veteran event that you can. Make sure the people in your community know that you are the person and veteran organization to contact when it comes to supporting veterans.

At the end of the day talking the talk and walking the walk will bring a more positive response and ensure that the new generation of Marines will know that they are not alone and have a family within the League.

#### **Associate Member of the Year**

This change/addition would be for a RIBBON ONLY. <u>APPROVED WITH "A" IN RIBBON instead of an EGA.</u> Department Chief of Staff Roger Ware has the letter "A" for sale for your Associate Member of the Year and the Eagle/Globe/Anchor device for sale for Marine of the Year awards.

Section 300 (h) of the National Administrative Procedures outlines the criteria for selection of the National Marine of the Year. Using these

provisions, the following Mideast Division MOY recipients are the committee to select a 2022 Mideast Division Marine of the Year and the Associate Member of the Year. The Chairman is Frank Mathers - Department of Delaware. The other committee members are: Richard Tanner - Department of Delaware; Roger Ware, Mike McLain, Rick Shank and Scott Kirby - Department of West Virginia; and Jeffrey Jones and Rick Thomason - Department of North Carolina. The guidelines in Section 300 (h) (2) of the above reference must be followed for each nomination. Please insert "Division" in lieu of "National", as appropriate. Any regular member from the Mideast Division can be nominated and the Mideast Division MOY will be presented at the 2022 Mideast Division Conference. Any Associate member from the Mideast Division Conference.

Each letter of nomination must be mailed to the above chairman, registered return receipt, post marked not later than May 17, 2022. Mail to Frank Mathers, Mideast Division Chairperson Marine of the Year or Associate Member of the Year Committee, 17 Fairway Drive, Ocean View, Delaware 18870. Telephone: 301-520-8051. It must have a cover letter signed by the Detachment Commandant and Adjutant or other officers if one of them is nominated. A second inner envelope must be addressed to the Mideast Division Chairperson Marine of the Year or Associate Member of the Year Committee. It must be sent Certified, Return Receipt Requested for your records, before the postmark deadline. The Marine of the Year Committee will announce the 2022 recipient during the Mideast Division Conference. The above provisions are for 2022 Marine of the Year or Associate Member of the Year selection only.

#### Division Marine of the Year (MOY) and Associate Member of the Year (AMOY) Criteria

These awards shall be presented to a REGULAR MEMBER or Associate Member of the Marine Corps League who has rendered service(s) and/or performed a deed(s) above and beyond the duties and obligations required of a member of the Marine Corps League, or a meritorious deed(s) so identified as being within the scope of these rules shall be of such substance that the weight will or shall have brought acclaim and prestige to the Marine Corps League; or has enhanced and/or furthered the concepts of the duties of being a citizen of the United States of America; or a deed(s) of courage or valor without regard for his/her own safety

Letters of nomination must originate only at the DETACHMENT LEVEL. No individual nor any subsidiary unit of the Marine Corps League shall submit a letter of nomination.

All letters of nomination shall include a letter signed by the Detachment Commandant and Adjutant, stating that the nominee for Division Marine of the Year or Associate Member of the Year was approved at a regular meeting of the detachment by a majority vote. (In the event a nominee is the Commandant, the letter of nomination shall be signed by the Senior Vice Commandant and the Adjutant. In the event a nominee is the Detachment Adjutant, the letter of nomination shall be signed by the Detachment Commandant and Senior Vice Commandant). Each nomination submitted shall be placed in a sealed envelope and addressed to "Chairperson, Division Marine of the Year or Associate Member of the Year Society". THIS ENVELOPE SHALL THEN BE PLACED IN ANOTHER ENVELOPE and mailed, certified/return receipt requested, to: the Chairman at the address listed on the announcement.

The member must be a member in good standing and have served at least either an elected or appointed Associates position within his detachment and department. List how many years he has been a member. List his positions and what was the significance of each if any. Is he a Detachment level or Department level Marine of the Year or Associate Member of the Year?

The recommendation should summarize what the member has done in his detachment, and or department. It should be brief and only impact areas where the candidate performed that brought credit upon his detachment and not merely list that he performed the duties expected of his position and or attended meetings. What were the results of any activities he participated in that were above the normal expected duties of his position? List those activities where he was the chairman or committee lead. Examples: Toys for Tots for 15 years and how many toys collected and how many children benefited. Chairman of numerous fund-raising events that benefited the detachment or selected charities. What was the total amount generated? Did he teach flag etiquette or flag folding to children, how many classes and how many kids for how many years? What civic projects or volunteer did he do to enhance the league? If he did not participate as a league member in an event or activity, do not list it. What did he do as a volunteer outside of his detachment for the league? Was he recognized within his community for a project?

The nomination should be a snapshot of the member's achievements and not just listing his MCL awards. Did he attend his Department quarterly meetings or Convention, Mideast Division Conference, National Mid-Winter Staff Conference, or National Convention?

The Division MOY or AMOY Committee has developed a point system to aid them in their selection process. Consideration can be giving a point for each event, and a point giving for participation outside his Detachment for either serving on Department, Division or National level and on any committee.

#### 988 - Nationwide 3-digit dialing code for mental health crisis and suicide prevention

You may have heard that on July 16, 2022, 988 will become the nationwide 3-digit dialing code for mental health crisis and suicide prevention. It will replace the 1-800 number currently used by the National Suicide Prevention Lifeline. On this date, when someone calls 988 all phones in the U.S. (mobile and landline) will connect with the mental health crisis/suicide prevention system. This will allow anyone in the U.S. to call 988 and get help designed specifically for someone dealing with a mental health crisis.




